**Fields Corporation establishes “Okinawa Working Center”
to Promote the Employment for People with Disabilities.
The Company realizes the Employment of People with disabilities between Tokyo and Osaka,
by utilizing the remote employment service of WINGLE Co., Ltd.
~Aiming at the support for the sports advancement through the employment as a part of CSR promotion activities ~**

Fields Corporation (Head office: Shibuya-ku, Tokyo; President and COO: Takashi Oya; JASDAQ: 2767; “Fields Corporation”), developing various range of business in entertainment field, employs 6 persons with disabilities and opens for business in Okinawa from April 1st, by utilizing the remote employment service provided by WINGLE Co., Ltd. (Head office: Sendai City, Miyagi; Representative Director/President: Atsumi Hasegawa; “WINGLE”) which is engaged with the employment promotion business for people with disabilities. Furthermore, the opening ceremony of the “Okinawa Working Center” will be held on Wednesday April 5.

1. Purpose and background

The social role and the importance of purpose of employing personnel with disabilities in the companies is getting more meaningful through the progress of related laws.

In the circumstance, Fields Corporation is doing the corporate activities to contribute to a creation of an affluent society to achieve “The Greatest Leisure for All People” as its corporate philosophy.

Fields Corporation hereby establishes “Okinawa Working Center” in Okinawa City, Okinawa as of April 1, as a part of CSR activities and hired 5 persons at the opening. The Company is planning to expand the number of the employees and aims to be a specialized company in the future. Fields Corporation continues to push forward with achieving an affluent society and keeps the social responsibility through offering the employment opportunities and a comfortable working place to people with disabilities.

2. The introduction overview

WINGLE manages a working space in Okinawa at which numbers of companies tenant, and introduces people with disabilities, who live in Okinawa, to the Companies to promote the employment. Fields Corporation employs people with disabilities and they carry out the business, such as data input, at the office (only Fields Corporation use) in the working space. The staffs exclusively for Fields Corporation are stationed in the office to support the employees with their jobs and mental matters. Fields Corporation hires people with disabilities including members of Japan National Wheelchair Rugby team, Mr. Susumu Nakazato : a national team member (Starting for employment as of May 1) and Mr. Akihito Sunagawa : a national team candidate (Started for employment as of April 1), which means that the Company also supports a promotion of the sports for people with disabilities through the employment.
